PRESS RELEASE

On Friday, January 01, 2016, Buchanan County Sheriff's Deputies arrested Margaret Earline Joyner, 58, of Hazleton. Joyner was arrested and charged with Driving While License Barred (serious misdemeanor) and Operation without Ignition Interlock Device as Required (simple misdemeanor). This arrest was made after a Deputy Observed Joyner operating a vehicle in the 400 blk Sufficool Street in Hazleton.in this arrest.
