PRESS RELEASE

On Wednesday, June 01, 2016, Buchanan County Sheriff's Deputies arrested Ashley Nicole Musick, 26, of Hazleton, Anthony Michael Euvino, 35, of Oelwein, Janita Kay Brown, 39, of Hazleton and Denise Kay Munoz, 39, of Waterloo. Musick was arrested and charged with Driving While License Barred (aggravated misdemeanor), Driving While License Suspended (simple misdemeanor), Failure to File SR22 Insurance as Required (simple misdemeanor) and Operation without Ignition Interlock Device (simple misdemeanor). Musick was also cited for Failure to Carry Proof of Insurance and Failure to Carry Registration. Euvino was arrested and charged with Harassment of a Public Official (simple misdemeanor) and also had an active arrest warrant out of Black Hawk County. On Sunday, June 05, 2016 at approximately 5:30 am, Buchanan County Sheriff's Deputies responded

to a report of a motor vehicle accident near mile marker 49 on I380 east of Brandon. According to the investigation, a 2001 Dodge Durango operated by Deontai Rayquan Sallis, 19, of Waterloo, was traveling northbound on I380 when Sallis lost control of the vehicle and struck a guard rail approach to an overpass. The vehicle came to rest on the I380 overpass of 330th Street. Sallis four passengers were able to exit the vehicle and were later met by deputies. PRESS RELEASE

On Monday, June 27, 2016 at approximately 4:45 pm, Buchanan County Sheriff's Deputies responded to a report of a motor vehicle accident near the 256 mile marker on Hwy 20. According to the investigation, a 2002 Peterbuilt semi operated by Gregory Stalker of Maquoketa was traveling eastbound on Hwy 20 near the 256 mile marker. Stalker was in the passing lane and, while looking in his mirror to make sure his trailer was clear of another vehicle he had just passed, attempted to merge back into the outside lane.
